SAME DAY RIDE REQUEST

A rider may request a "same day" ride <u>within</u> Lee and/or Ogle Counties <u>provided there is availability on a bus</u>. Call dispatch to confirm availability. **(815) 288-2117**. <u>Same day</u> <u>rides can NOT be provided for medical appointments in</u> <u>Rockford however</u>. A same day ride request will include a \$3.00 fee in additional to the regular fee for the ride.

CANCELLATIONS / NO SHOWS

If a rider cancels a ride the same day for which it was to be provided, a \$2.00 charge will be applied. If a rider is a "no show" for a scheduled ride, a \$5.00 fee will be assessed to the rider.

* Children five years and younger must ride in an age appropriate car seat and be accompanied by an adult chaperone (18 years and older) who will not be charged for the ride on LOTS.

** The out-of-town fare for older adults (60+) veterans and disabled individuals is capped at \$5.00 one-way. A \$10.00 cap applies for round-trips for this population.



Lee-Ogle Transportation System, Greyhound Lines and the Illinois Department of Transportation have partnered to bring InterCity Bus Service to residents living along the Interstate-88 and Interstate-39 corridors.

The Greyhound Connect route along I-88 includes two daily round trips between Chicago and Davenport, Iowa. Stops along this route include the cities of Chicago, Naperville/ Aurora, DeKalb, Rochelle, Dixon, Moline and Davenport.

A second Greyhound Connect route runs between Chicago and Danville. This route has one daily round trip with stops in: Chicago, Elgin, Rockford, Rochelle, Oglesby, Bloomington-Normal, Champaign-Urbana, and Danville.

Lee Ogle Transportation System (LOTS) is here to help you get to where you need to go! We provide demand response service (from your front door to your destination and back home) to all ages. LOTS vehicles are equipped with lifts for persons with disabilities or those with limited mobility.

SCHEDULE YOUR RIDE

To make a ride reservation call LOTS Dispatch toll-free at 888-239-9228 or (815) 288-2117. **IN-TOWN RIDES** (within your zip code) require 24 hour notice. We prefer 48 hours notice for **OUT-OF-TOWN** rides (outside of your zip code). The daily deadline to make a ride reservation for in-town or out-of-town rides is 2:00 PM (Monday –Friday).

Passengers are encouraged to call LOTS as soon as they are aware of the need for a ride. For instance if you know of a doctor's appointment in two weeks, schedule your ride the same day you schedule your appointment with the doctor. The doctor's office may be able to assist you with making the ride reservation.

MEDICAL AIDES / CHAPERONES

Medical aides and adult chaperones for children (5 years and younger) are encouraged to ride and at no cost. DRIVERS ARE NOT ABLE TO ASSIST RIDERS TO OR FROM THE BUS. Please be advised LOTS is not able to provide transportation in the event you are experiencing a medical emergency. Please contact 9-1-1 in those instances.

ROCKFORD ROUTE

Three times a month, LOTS provides a route to Rockford for persons with medical appointments or who would like to go shopping. If you have a medical appointment and book a ride for this route, please schedule your medical appointment for between the hours of 9:00 AM and Noon. Call dispatch to confirm dates for the Rockford route. Seats for this route fill up quickly. If you need more information call dispatch at (815) 288-2117. SENIORS, VETERANS AND PERSONS WITH DISABILITIES

Older Adults, Veterans and Persons with Disabilities are frequent users of LOTS and find value in public transportation. These groups are able to ride at a reduced rate. A one-way, intown trip is \$1.00 and \$2.00 for a round-trip. If seniors, veterans or a disabled person will be traveling out of town a one-way fare of \$.35/mile be charged (capped at \$5.00). A \$10.00 cap applies for round-trips for these riders.

PUBLIC NOTICE REGARDING TITLE VI COMPLIANCE

Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving Federal financial assistance.
